TIPS FOR THE TABLE FROM JIM SLINGER

Tip 1—Bid more with shape, less with balanced hands. Inexperienced players typically underbid hands with good shape, and often overbid balanced hands, perhaps being too influenced by high card point count. This applies especially with a fit, but players often underestimate the promise of good shape, while overestimating the safety of a lot of points in a balanced hand. AKxxx, AKxxx, xx, x offers more hope of game as Dealer, and more safety in competing later, than AQx, KJx, Axx, KJx does. AK10xx, K98xx, xx, x is a clear cut opening bid, while A10x, K98, Qxxx, Kxx is a questionable opening bid at best. Specific recommendations: (1) In competitive auctions when holding a shapely hand with a fit for partner, (a) bid as high as possible immediately, and (b) take the push to a higher level despite minimum HC values if the bidding has gone more slowly; (2) In competitive auctions with a balanced hand and defensive values, do not take the push to a higher level despite holding a maximum HC values for your previous bidding. Instead, consider pulling out a red card; (3) When counting your points, deduct 1 point whenever holding 4-3-3-3 shape. Thus, if partner opens a 15-17 1 NT, pass with 8 HC and 4-3-3-3, and merely invite game with 10 HC and 4-3-3-3 shape.

Tip 2—If your opponent thinks a long time and passes, so should you. Of course, we are talking only about your borderline decisions here, but this is a consideration worth paying attention to. The rationale is that your opponent is doubtful that he or she is in the right contract, and that doubt will often turn out to be appropriate.
